WC/WCX: Mitch White, Karen Wilson and John Drennen

Birds: Ducks in all WC/WCX (No live ducks will used. Permission has been granted by GRCA)

Prizes: Rosettes and Duck Bands will be awarded to all WC/WCX qualifiers

ENTRY FEES: Working Certificate \$85.00 Working Certificate Excellent \$100.00 (There will be a \$20.00 fee for returned checks)

The Working Certificate test is limited to 15 dogs. Working Certificate Excellent test is limited to 12 dogs.

Priority for spots are provided to MSCRC members. Next priority is golden retriever owners. Then if more entries than the number of allotted spots are received by the closing date and time a lottery will be held to determine who will fill the spots.

If there are extra spots available Non-Golden breed handlers may obtain a spot. However, the handlers will be required to provide and submit the proper qualifying paperwork for the test to their respective breed club.

Directions to Turnagain Pass Test Site:

From Anchorage – South on Seward Highway to Turnagain Pass, approximately ¼ mile past the rest areas on the right is a gravel road, turn right and go down the hill, this is Lyons Creek. It is approximately 50 miles, a 1-hour drive from Anchorage.

Other Instructions/Information: Bitches in season are not allowed on the grounds. Refunds will be made for bitches in season or injured dogs, if a veterinarian's certificate is provided. Requests for refunds, along with the veterinarian's certificate, must be received by the secretary no later than 10 days following the event. Mail to the Test Secretary at the above address. Entry fee minus \$15.00 will be refunded.

Mail or bring a copy of the AKC registration for a title. No titles can be received without the AKC registration. A copy of the pedigree or just the AKC registration number are not acceptable. Per GRCA rules and regulations. Certificates will be awarded by GRCA and mailed directly to the owner of the golden retriever.

On test day MSGRC will award a rosette and duck band to each dog, that in the opinion of the judges, satisfactorily completed the test, as tangible proof that the dog has qualified.

DOGS MUST BE ON LEASH AND UNDRE CONTROL AT ALL TIMES EXCEPT WHEN THEY ARE RUNNING IN THEIR ENTERED STAKE.

Food
