→ Trial Times:

Saturday – Obedience Trial starts at: 10:00 AM; Rally Trial starts at 11:45 AM. Building open from 8:30 AM – 3:30 PM.

Sunday – Obedience Trial starts at: 10:00 AM; Rally Trial starts at 11:30 AM. Building open from 8:30 AM – 3:30 PM.

→ **Transfers:** As a courtesy, please let the Trial Secretary know about transfer requests prior to the trial date, if possible. Transfers will be accepted until 30 minutes before the trial begins. → Obedience Exhibitors:

Check-in, confirm jump heights, and pick up your armbands at the Ring Steward Tables. Ring 1 is on the left and Ring 2 is on the right. Check the Judging Program for ring assignments.

→ Rally Exhibitors:

A self-check in table will be set up in the foyer. Check in is available at 10:30 AM on Saturday and 10:30 AM on Sunday. Please mark your dog as checked-in, confirm jump heights and pick up your armband. If there is nothing on the table, check-in with the Ring 1 Table Steward.

Turn Right

ACT is mid-way in the strip mall to the right

From South Anchorage & Kenai Peninsula:

Follow Seward Hwy to Dimond Blvd Exit
Travel West on Dimond for 3 miles to “C” Street
Turn Right and follow “C” St to International Airport Road
Turn Left and travel 0.2 miles
549 W. Int’l Airport Road is on the Right (turn in at Party World sign)
ACT is mid-way in the strip mall to the right

From Anchorage International Airport:

Follow International Airport Blvd and travel East 2.5 miles
549 W. Int’l Airport Road is on the Left (turn in at Party World sign)
ACT is mid-way in the strip mall to the right
