Sunday – Obedience Trial starts at: 10:00 AM; Rally Trial starts at 11:25 AM. Building open from 8:30 AM – 3:30 PM.

→ **Transfers:** As a courtesy, please let the Trial Secretary know about transfer requests prior to the trial date, if possible. Transfers will be accepted until 30 minutes before the trial begins. Turn Left and travel 0.2 miles  
549 W. Int'l Airport Road is on the Right (turn in at Party World sign)  
ACT is mid-way in the strip mall to the right

#### From Anchorage International Airport:

Follow International Airport Blvd and travel East 2.5 miles  
549 W. Int'l Airport Road is on the Left (turn in at Party World sign)  
ACT is mid-way in the strip mall to the right
