Our fees are the same now as last year with the fees based on a fee per dog, however if you have 6 or more dogs you are discounted from the regular fee.

Cost of the eye exams are:

1 dog =	44.00
2 dogs =	88.00
3 dogs =	132.00
4 dogs =	176.00
5 dogs =	220.00
6 dogs =	240.00
7 dogs =	275.00
8 dogs =	310.00

PLEASE NOTE:

Any individual dog count over 8 will be 38.00 more per dog. Example: 8 dogs = 310.00 + 38.00 = 348.00 for 9 dogs total

PLEASE NOTE: If you have more than 8 dogs just add 38.00 for each additional dog and enter that amount in the (Price per Item) area. If you have questions email Bob Fabrizzio: robfab@mtaonline.net

CREDIT CARDS ARE NOW BEING ACCEPTED THROUGH PAY PAL!

We are able to now offer you this through the WGDC Website, www.wgdca.org, which means you will now be able to use a credit card for payment or you can still send a check or cash for payment. Further instructions will be included on the sheet attached.

Once you pay through through the website, an invoice is generated and you will receive it almost immediately. I will also get it and send you an email for scheduling purposes. If you like, you can send an email requesting your location and time slot for the number of dogs you need done and I will confirm this for you once I receive your payment notice. For those doing walk in payments, unless you have a phone that can access internet, you will have to pay by check or cash, no option. ALL scheduling will be by email...NO Messenger or FACEBOOK as I cannot track them.

For all appointments to be guaranteed your payment must be received no later than 8 Feb 2019. You can change your appointment but I need to know ASAP so we can get you in for a time slot that will still work for you.

PLEASE NOTE: This is for all dogs, not just those that are breed recognized.

IMPORTANT NOTE: For those of you who will require an appointment based on your vet for eye injuries, your vet needs to contact Dr. Scherlie first. Fees will be charged accordingly and payment is due at that time if appointments are available. These appointments will only be available in the late afternoon for both days.

PLEASE NOTE: If you try and use the appointment for other than the CERF, you will be charged on top of this fee and Dr. Scherlie will advise you of that fee at that time.
